Storm Water Services

filed General Storm Water Permit Notice of Intents (NOIs) in California, Oregon, Washington, Colorado, Alabama and Louisiana, and prepared small MS4 Phase II permit documents.

Overall Storm Water Services:

- Preparation and implementation of SWPPPs that incorporate cost effective Best Management Practices (BMPs);
- Development and implementation of water quality Monitoring and Reporting Programs (MRPs);
- Preparation of water quality monitoring work plans and Sampling and Analyses Plans (SAPs);
- Development and implementation of Storm Water Management Programs (SWMPs) for Phase I and Phase II Municipal Separate Storm Water Systems (MS4s);
- Assessment and reporting of storm water and ambient water quality monitoring data for regulatory compliance;
- Storm water and water quality sample collection;
- Design and inspection of storm water collection and retention systems;
- Conducting industrial and construction site inspections for storm water compliance; and,
- Preparation of Industrial General Permit (IGP), and Construction General Permit (CGP) Permit Registration Documents (PRDs).



Since 2003, Condor has provided storm water monitoring activities for the City of Stockton and County of San Joaquin's National Pollutant Discharge Elimination System (NPDES) Storm Water Permit. Condor has successfully coordinated and conducted regulatory-directed water quality monitoring programs that included urban waterways and urban discharge and receiving water monitoring locations.
